

Report in the Selection Process for the Post of Clerk – Part-time on a back to back basis, Year 2015.

Following the approval from the Department of Local Government, on the 2nd March 2015, an internal call for application was issued, and no candidates applied.

The call was subsequently issued through the ETC. A list of 158 applicants was forwarded, and 22 applications were received by the stipulated deadline.

A short listing process was made, eliminating those not eligible for various reasons, such as insufficient qualifications, and candidates not on the ETC list. Those indicating clearly that were looking for summer job, were also eliminated.

A communication to all remaining applicants was set so as to clearly indicate that the job is for a long term and for fixed hours, upon which a number of applicants withdraw their application.

Following the above filtering process, 7 Candidates were allocated an interview time. These were held on Monday 13th April starting at 16.00 hours. The Board members present during the selection process was made up of the Executive Secretary Svetlick Flores, Vice Mayor Matthew Paris (attended as from the 5th Interview), and Councilors Davina Sammut Hili, and Vincent Borg. One candidate (Maria Lara Sultana) did not turn up, whilst during the interview it emerged that a two applicants (Michael Calleja, and Kevin Psaila) were only seeking a summer job, or were determined in continue studying. These asked for the possibility of flexibility hours, which was not conceded. Thus 4 candidates were considered and subsequently carried on with the interview, upon which a score was awarded (Listed in order of attendance)

Candidate: Jonathan Camilleri – Scored an average of 44.7 out of 100

Candidate: Maurovic Catania – Scored an average of 55.8 out of 100

Candidate: Sylvia Zahra – Scored an average of 80.5 out of 100

Candidate: Mark Anthony Bonello – Scored an average of 48.8 out of 100

Following the interviews held and the subsequent score that the candidates obtained, the board is of the recommendation that 2 candidates are suitable in the following order of merit:

1 – Sylvia Zahra

2 – Maurovic Catania
