1. KUNSIDERAZZJONI U APPROVAZZJONI TAL-MINUTI

- 1.1 Il-Minuti gew approvati kif ipprezentati u ffirmati mis-Sindku u S-Segretarju Ezekuttiv. Proposti mis-Sinjura Magda Magri Naudi, sekondant Dr. Marc Sant. Gew ukoll approvati lista ta' pagamenti.

2. MEPA

- 2.1 Is-Sindku Dr. Ian Castaldi Paris, tkellem dwar zvilupp fi Triq Merino. Huwa fakkar li ghalkemm dan il-permess gie rrifjutat fuq insistenza tal-Kunsill issa hemm process ta' appell biex jissanzjonaw l-izvilupp illegali li hemm f'dan is-sit. F'Settembru li ghadda dan il-Kunsill kien ghamel konferenza ta' l-ahbarijiet fejn kien spjega kif ma nistawx nibqghu nisanzjonaw bini li fih ikun hemm illegalitajiet. Dan il-Kunsill kien insista li mhux ser jaccetta li f'Hal Lija bini illegali jigi sansjonat u ghalhekk kien ghamel appell lill-MEPA biex dan il-kaz partikolari jinghata attenzjoni specjali.

2.2 Fl-ahhar seduta tal-board tal-MEPA li nzammet xi hmistax ilu, dan l-istess board ried li l-applikant jissotometti 'fresh plans' u huwa propju hawn fejn il-Kunsill ghandu juri d-disprovazzjoni tieghu.

3.2 LOCAL COUNCIL ENTERPRISE SUPPORT AWARD & GREEN CHALLENGE AWARD.

Upgrading of a green area through the planting of more trees and shrubs and the installation of street furniture.

Submitted application to Local Councils Department.

3.3 CPPS FUNDING FOR AN URBAN GREEN TRANSPORT SYSTEM

Request for the consideration by MEPA of a proposal of a green public transport system within the village of Lija, the development of which would be partially financed out of CPPS Funds. Submitted application to MEPA

3.4 FONDI SPECJALI GHAL LOKALITAJIET BI BZONNIJAIET SPECJALI

Request for the resurfacing of Transfiguration Avenue. Submitted application to Local Councils Department

3.5 URBAN IMPROVEMENTS FUNDS

Presented three proposals for the request from UIF Funds :

- a. children's playingfield
- b. 5-aside football pitch – Recreational Centre
- c. Erection of new ornamental lanterns

3.6 EVENTS INITIATIVES SCHEMES 2010

Presented application form re Citrus Festival which is to be held in January 2010, Venue : Villa Lia, Main Street, Lija

3.7 SPORTS INITIATIVES SCHEME

Presented application form with the following proposals:

- a. Hiring of football pitches during the period when out training grounds are being converted from sandy to synthetic grass surface.
- b. Providing in-house football training by out qualified coaches at Lija Primary School to school students.
- c. Hiring of gymnasium facilities and service of qualified coaches for training in volleyball and basketball.
- d. The organization of a sports festival to entice people of all ages to take up a sports and become physically active.

4. GREEN WARDENS

4.1 Fuq proposta tas-Sindku, Dr Ian Castaldi Paris, sekondat mill-Vici Sindku s-Sinjura Magda Magri Naudi, il-Kunsill unanimament approva b'effett immedjat biex jibda s-servizz tal-green Wardens fil-lokalita ta' Hal Lija.

4.2 Dawn huma Wardens pajzana li ser ikunu qed iduru l-gurnata kollha inkluz il-'weekends' sabiex jizguraw li hadd ma jhammeg bi kwalunqwe skart dan ir-rahah tant sabih taghna. Ghal din ir-raguni ghandu jinbaghat avviz lir-residenti kollha ta' Hal Lija biex jigu infurmati b'dan is-servizz gdid tal-Green Wardens u biex inheggu lill-kullhadd jipparticipa f'din il-kampanja ta' ndafa fil-lokalita.

5. TRAFFIC MANAGEMENT

5.1 Il-kunsilliera tkellmu dwar il-problema dejjem tikber tat-traffiku gewwa ir-rahah ckejken ta' Hal Lija. Din il-problema tibda bit-traffiku esagerat li jidhol minn naha ta' H'Attard il-fuq minn naha tal-Mirakli u aktar l-isfel minn Triq Kananea. Bhala rizultat ta' dan, it-triqat fil-qalba tar-rahah b'mod specjali Triq Sant Andrija, Triq il-Forn u Triq il-Kbira qed ikunu ta' periklu ghar-residenti ta' dawn it-toroq biex johorgu minn djarhom.

5.2 Fuq proposta tas-Sindku, Dr Ian Castaldi Paris, il-kunsilliera unanimament qablu biex issir ittra ufficjali lic-Chairman ta' l-Awtorita Dwar it-Trasport, lill-Perit David Vassallo, biex tintalab li jsir ezercizzju mill-Awtorita dwar it-Trasport fil-lokalita ta' Hal Lija u b'mod specjali fit-toroq imsemmija hawn fuq minhabba li hemm periklu kbir bhala rizultat ta' sewqan eccessiv u traffiku esagerat ghat-tip ta' toroq li hawn f'hal Lija.

5.3 Il-Kunsill jixtieq ihalli f'idejn id-Dipartment ta' l-ADT sabiex dan jiggwida lill-Kunsill kemm jista' jkun malajr sabiex jispicca l-periklu f'din l-akkwata.

6. AFFARIJJIET OHRA

6.1 Is-Sinjorina Lorraine gibed l-attenzjoni biex issir zabra ta' sigar fi Triq tal-Mirakli u biex jitnaddaf il-Housing Estate.

6.2 Dr Marc Sant tkellem dwar 'request' biex il-parking fil-bidu ta' Triq Trasfigurazzjoni ikun regolarizzat bil-hin. Ghandha ssir 'query' dwar din it-talba lill-ADT. Huwa qal ukoll biex isiru traffic lines fi Triq Giovanni Barbara kantuniera ma' Triq Daniel Sammut u titwahhal traffic sign 'No Right Turn' fi Triq Mabel Strickland qabel iddur Triq Sir Ugo Mifsud. Huwa semma' ukoll is-sign tal-Bus Stop fi Triq in-Naxxar li ma hemmx sign imwahhla.

6.3 Is-Sur Jeremy Dalli gibed l-attenzjoni biex il-linji sofor tat-traffiku fi Triq il-Kuncizzjoni jergghu jinzebgħu.

6.4 Is-Sinjura Magda Magri Naudi gibed l-attenzjoni dwar id dawl tat-Torri. Ghandu jitqabbad l-'electrician' biex jiehu hsieb jirrange din il-problema.

6.5 Is-Sinjorina Lorraine Farrugia tkellmet dwar problema ta' parking fi Triq Preziosi fejn hemm iz-zewg hwat quddiem id-dar nr 43 u jekk hux possibli li dawn il-hwat jitnehhew biex isir parking space.

Is-Sindku qal li dawn il-hwat ilhom hemm mill-ewwel kunsill jigifieri madwar hmistax il-sena. Għar raguni li t-triq hija dejqa anke jekk jitnehhew il-hwat, jekk isir parking space jinholq periklu għar-residenti u tkun diffiċli għal dawk li joqghodi fil-parti ta' fuq ta' din it-Triq biex jghaddu bil-karozzi tagħhom. Kull tibdil f'din iz-zona isir fuq il-parir ta l-ADT
